Due to unavoidable circumstances, the Schedule of the Half Yearly Examination, 2021-22 for below stated subjects of classes III to VIII in all the Government (State &TTAADC managed) Schools excluding CBSE affiliated State Government Schools; Government Aided Schools, and Madrasas with SPQEM Madrasas which was earlier, notified vide memo No. F.4 (254)-DEE/GEN/2019/2671-75 dated 4th December, 2021 is hereby cancelled.

Now, the fresh schedule for the above referred Half Yearly Examination with respect to below stated subjects of classes III to VIII is hereby notified as below.

In this regard, in continuation of earlier communication following are mentioned

- Question Papers for above subjects will be framed by the Centralized Examination Unit for Elementary Level on the basis of reduced syllabus, focused syllabus, basic skill (i.e. Foundational Learning & Numeracy) and with the design of question paper, as already conveyed vide this Directorate Memorandum No. No F.4 (254)-DEE/GEN/2019 (L-III) /12475-79 Dt. 23.11.2021
- Consequent upon reduced assigned marks as 70 for each subject (instead of 100, as was in revised scheme of assessment) for the session 2021-22 only, the duration for each subject in Half Yearly examination, will be of 2 (two) hours and 30 (Thirty) Minutes, as cited in the above table.
- c) Beside, Questions on (i) Sanskrit/Alternative Hindi for classes VII and VIII, (ii) Chakma / Halam / Kuki-Mizo / Garo / Mog / Manipuri / Bishnupriya Manipuri / Hindi / Arabic Studies /Islamic Studies etc. as appropriate for the students of classes of III - VIII will be framed by the respective Schools Authorities like preceding examination(s) and examination for these will be conducted by the respective School authorities as per their conveniences.

d) Prescribed provision for allowing compensatory time @ 20 minutes per hour (i.e. 50 minutes in Half yearly examination, 2021-22) to the students with benchmark disabilities to be complied. Student who desires to avail the benefit will have to produce the disability certificate issued by the Competent Authority.
