Whereas, Lt Abinash Das Ex-UGT of Indrajoy Chakma Para SB School under HO & DDO Inspector of Schools Gandachara Dhalai, Tripura, expired on 13/05/2022 while in service. The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

Whereas, Lt Abinash Das Ex-UGT expired at the age 53 years 05 month 13 days and there is no earning member in the family as per the report of the SDM, Kamalpur, Dhalai, Tripura his wife Smt. Shikha Rani Das Deb is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Abinash Das Ex- UGT is 30/11/1968 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Shikha Rani Das Deb is eligible to get a Special Pension for the period w.e.f 14/05/2022 to 29/11/2028.

And

Whereas, the last basic pay of Lt Abinash Das Ex- UGT was Rs.46400/- and as per PPO No.142340685 dated 20-01-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.23200/- P.M for the period w.e.f 14/05/2022 to 13/05/2032.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Shikha Rani Das Deb W/O Late Abinash Das Ex- UGT @ Rs (46400-23200)=Rs 23200/- + Admissible DR+ 8% DA w.e.f 14/05/2022 to 30/11/2022 & @ Rs (46400-23200)=Rs 23200/- +Admissible DR+ 20% DA w.e.f 01/12/2022 to 29/11/2028 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
