Whereas, Lt Nripendra Kr Roy UGT of Palanpara JB School under HO & DDO Inspector of Schools Dukli,,West,Tripura,expired on 02/01/2023.while in service. The case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18,dated 02/03/2019.

Whereas, Lt Nripendra Kr Roy Ex-UGT expired at the age of 59 years and there is no earning member in the family in the family as per the report of the SDM, Teliamura,Khowai,Tripura his wife Smt. Smriti Rani Saha Roy is entitle under **Support Category-1(one)** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

Whereas, as per the service record the date of birth of Lt. Nripendra Kr Roy Ex-UGT is 01/01/1964 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Smriti Rani Saha Roy is eligible to get a Special Pension for the period w.e.f 03/01/2023 to 31/12/2023.

And

Whereas, the last basic pay of Lt Nripendra Kr Roy Ex-UGT was Rs.52200/- and as per PPO No.142344112 dated 11-09-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E),Tripura @ Rs.26100/- P.M for the period w.e.f 03/01/2023 to 31/12/2030.

Now, therefore the provisional special pension has been sanctioned in favour of Smt. Smriti Rani Saha Roy W/O Late Nripendra Kr Roy Ex-UGT @ Rs (52200-26100)=Rs 26100/- +Admissible DR+ 20% DA w.e.f 03/01/2023 to 31/12/2023 subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
