Sub: Sanctioning Provisional Special Pension in favour of Smt Sandhya Debbarma. W/O Late Pradip Debbarma, Ex-KBT of Debta Bari S.B School under HO & DDO Inspector of Schools Teliamura, Khowai, Tripura.

Whereas, Late Pradip Debbarma, Ex-KBT of Debta Bari S.B School under HO & DDO Inspector of Schools, Teliamura, Khowai, Tripura expired on **31/07/2020** while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas, Late Pradip Debbarma, Ex-KBT expired at the age of 58 years 09 month and there is no earning member in the family at the time of death on **31/07/2020** as per the report of the SDM Teliamura, Khowai, Tripura. His wife Smt Sandhya Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Pradip Debbarma, Ex-KBT is **31/10/1961** and as per the Notification of the GA(P&T) Department dated 02.03.2019. His wife Smt Sandhya Debbarma is eligible to get a Special Pension for the period w.e.f 01/08/2020 to 30/10/2021.

And

Whereas, the last basic pay of Late Pradip Debbarma, Ex-KBT was Rs.72600/- and as per **PPO No.142134830 dated 12/11/2021** the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E) Tripura @ Rs.36300/- P.M for the period w.e.f 01/08/2020 to 30/10/2028.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Sandhya Debbarma W/O Late Pradip Debbarma, Ex-KBT of Rs (72600-36300)=Rs.36300/- + Admissible DR.w.e.f 01/08/2020 to 28/02/2021 & Rs (72600-36300)=Rs.36300/- + Admissible DR +3% DA.w.e.f 01/03/2021 to 30/10/2021. Subject to condition to finalization by the Account General (A&E) Tripura and the amount will be debatable under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
