Whereas, Lt. Manik Lal Bhowmik. Ex-UGT of BC Manu SS VM H/S (Pry) School under HO & DDO AHM BC Manu SSVM H/S School, Santir Bazar, South Tripura. expired on 10/01/2023. while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment/ Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

Whereas, Lt Manik Lal Bhowmik. Ex-UGT expired at the age of 55 years 04 month 02 days and there is no earning member in the family as per the report of the SDM Santirbazar, South Tripura his wife Smt Rinku Bhowmik. comes under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.



Whereas, as per the service record the date of birth of Lt. Manik Lal Bhowmik. Ex-UGT. is 08/09/1967 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Rinku Bhowmik is eligible to get a Special Pension for the period w.e.f. 11/01/2023 to 07/09/2027.

And

Whereas, the last basic pay of Lt Manik Lal Bhowmik. Ex-UGT was Rs.47800/- and as per PPO No.142342645 dated 30-05-2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.23900/- P.M for the period w.e.f. 11/01/2023 to 10/01/2033.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Rinku Bhowmik W/O Late Manik Lal Bhowmik. Ex-UGT @ Rs (47800-23900)=Rs 23900/- +Admissible DR +20% DA w.e.f 11/01/2023 to 07/09/2027. subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension, 04-Pensionary Charges (2271-01-105-02-01-04).
