**Whereas,** Lt Subha Ranjan Debbarma.Ex- A/T expired at the age of 53 years 10 month 17 days and there is no earning member in the family as per the report of the SDM, Jampuijala, Sepahijala, District his wife Smt Subha Rani Debbarma is entitle under **Support Category-1** in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

**Whereas,** as per the service record the date of birth of Lt. Subha Ranjan Debbarma.Ex- A/T is 14/11/1969 and as per the Notification of the GA(P&T) Department dated 02.03.2019, his wife Smt Subha Rani Debbarma is eligible to get a Special Pension for the period w.e.f. 02/10/2023 to 13/11/2029.

**Whereas,** the last basic pay of Lt Subha Ranjan Debbarma.Ex- A/T was Rs. 62600/- and as per PPO No.142445779 dated 23-02-2024 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura @ Rs.31300/- P.M for the period w.e.f. 02/10/2023 to 01/10/2033.

**Now,** therefore the provisional special pension has been sanctioned in favour of Smt Subha Rani Debbarma, W/O Late Subha Ranjan Debbarma. Ex-A/T @ Rs (62600-31300)=Rs 31300/- + Admissible DR+ 20% DA w.e.f 01/10/2023 to 31/12/2023 & Rs (62600-31300)=Rs 31300/- + Admissible DR+25% DA w.e.f.01/01/2024 to 13/11/2029.subject to finalization by the Account General (A&E) Tripura and the amount will be debit able under Head of Account 2071-Pension & Other benefits, 01-Civil, 105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
