MEMORANDUM

Whereas, Sri Saikat Talapatra, UGT of Bapuji Vidyamandir High School (Primary Section), Agartala, West Tripura joined the Govt. Service on 11-12-2006 ;

Whereas, it is observed that Sri Saikat Talapatra, UGT while posted at Bapuji Vidyamandir High School (Primary Section), Agartala, West Tripura had remained absent without authorization from duties in different spells w.e.f. 02.02.2016 to till date.

AND

Whereas, a Show Cause dated 14/03/2018 along with acceptance of joining on 08/09/2017 (w.e.f 02-02-2016 to 07/09/2017=585 days) of Sri Saikat Talapatra, UGT was issued pending regularization of his unauthorized absence period but no reply was received by this Directorate. Besides, reply of Show Cause issued dated 10/04/2018 was also not submitted by him.

AND

Whereas, the consolidated summary of the issue of unauthorized absence of Sri Saikat Talapatra, UGT was notified on 15/09/2018 to be published in the local dailies which was published in the Dainik Sambad on 17/09/2018 seeking explanation or causes of his unauthorized absence. But no response yet to be received from his end till date.

AND

Whereas, Sri Saikat Talapatra, UGT was referred on 29/01/2019 before the Standing Medical Board, A.G.M.C & G.B.P Hospital for ascertaining the genuines of his illness for the period 08/03/2018 to 12/08/2018 i.e. 158 days. The Board opined on 14/06/2019 that his produced Medical Illness w.e.f 08/03/2018 to 15/05/2018 for 69 days absence is justified. Remaining 89 days i.e w.e.f 16/05/2018 to 12/08/2018 opinion of Homeo Physician is needed. Although expert opinion sought for on 05/07/2019 & 26/11/2020 from the Director of Health Service, Gurkhabasti, P.N.Complex, Agartala but no report received by this Directorate till date.

AND

Whereas, on 28/04/2019 Sri Saikat Talapatra, UGT was arrested case No.29WAG084 Dt. 27.04.2019, U/S 120 (B)/501/509/384/506 IPC & Section 67 of the Information Technology Act, 2000 and detained custody for a period exceeding 48 hours and he was suspended w.e.f the date of detention vide dated 08/05/2019. Subsequently, he had been allowed subsistence allowance vide dated 13/09/2019.

AND

Whereas, the suspension order of Sri Saikat Talapatra, UGT was revoked pending finalization of the criminal case against him vide No.F.5(78)-DEE/DP/2019/86 dated 12/05/2021 and simultaneously posted his at Ratanmani Para High School, Dumburnagar, Dhalai District. But till date he did not join his new place of posting. Vide memo No. F.7(1-50PF)-DEE/Trg/2016/1193 dated: 09-09-2021 he was asked to explain within 10(ten)days of receipt of the memo as to why he should not be considered as deemed to have been resigned from Government Service as per vide No.F.1(1)-FIN(G)/86, dt 20/06/2013. But same could not deliver due to non availability of the person in address given to Department.

Now, through the instant memo Sri Saikat Talapatra, UGT is once again hereby asked to explain within 21-10-2021 as to why he should not be considered as deemed to have resigned from Government Service as per notification of the Finance Department vide No.F.1(1)-FIN(G)/86, dated 20/06/2013 failing which action will be taken *ex parte*. This notice will also be published in leading news papers of State and Departmental website.
