Sub: Sanctioning Provisional Special Pension in favour of Smt Tulsi Singha, W/O Late Samiran Sinha, Ex-UGT of Muslim Para JB School under HO & DDO Inspector of Schools Salema, Dhalai, Tripura.

Whereas, Late Samiran Sinha, Ex-UGT of Muslim Para JB School under HO & DDO Inspector of Schools, Salema , Dhalai, Tripura expired on 21/03/2022 while in service, the case comes under the purview of the 'Scheme for Compassionate Appointment' Benefit of Government employees of Tripura' vide Notification of the GA(P&T) Department No.F.1(1)-GA(P&T)/18, dated 02/03/2019.

And

Whereas,Late Samiran Sinha, Ex-UGT expired at the age of 58 years 07 months 18 days and there is no earning member in the family as per the report of the SDM Kamalpur, Dhalai, Tripura. His wife Smt Tulsi Singha is entitled under <u>Support Category-1</u> in accordance with the Notification of the GA(P&T) Department vide No.F.1(1)-GA(P&T)/18, dated 02/03/2019 and is eligible to receive Special Pension benefit till her deceased husband would have attained 60 years of age.

And

Whereas, as per the service record the date of birth of Late Samiran Sinha, Ex-UGT is 03/08/1963 and as per the Notification of the GA(P&T) Department dated 02.03.2019 his wife Smt Tulsi Singha is eligible to get a Special Pension for the period w.e.f 22/03/2022 to 02/08/2023.

And

Whereas, the last basic pay of Late Samiran Sinha, Ex-UGT was Rs.45000/- and as per PPO No.142340639 dated 16/01/2023 the enhanced family pension (EFP) has been sanctioned by the Accountant General (A&E), Tripura at the rate of Rs.26100/- per month for the period w.e.f 22/03/2022 to 02/08/2030.

Now, therefore the provisional special pension has been sanctioned in favour of Smt Tulsi Singha W/O Late Samiran Sinha, Ex-UGT at Rs(45000–22500)= Rs.22500/- + Admissible DR 3% w.e.f 22/03/2022 to 30/06/2022 & Rs (45000–22500)= Rs.22500/- + Admissible DR+8%.w.e.f 01/07/2022 to 30/11/2022 & Rs (45000–22500)= Rs.22500 /- + Admissible DR 20%.w.e.f 01/12/2022 to 02/08/2023 subject to finalization by the Accountant General (A&E) Tripura and the amount will be debitable under Head of Account 2071-Pension & Other benefits,01-Civil,105-Family Pension 02-Pension, 01- General Pension,04-Pensionary Charges (2271-01-105-02-01-04).
