MEMORANDUM

Whereas, Sri Ajit Datta, LDC of Education Inspectorate, Satchand & SNP, Sabroom, South Tripura 1st joined in Govt. Service on 16/12/2013(F/N) ;

AND

Whereas, Sri Ajit Datta, LDC of Education Inspectorate, Satchand & SNP, Sabroom, South Tripura had remained absent from duties since 06/09/2023 to till date without any intimation, as informed by the Inspector of Schools, Satchand & SNP Sabroom, South Tripura ;

AND

Whereas, the Inspector of Schools, Satchand issued two show cause notices dated 25/09/2023 and 10/11/2023 to Sri Ajit Datta, LDC for his unauthorized absence since 06/09/2023 to till the date of issue of the showcause notices. Both notices were received by Smt. Debi Bal (Datta) mother of Sri Datta. However, no response has been received from the employee to date.

AND

Whereas, the Directorate (DEE) issued three separate show cause notices dated 28/02/2024, one of which was received by Smt. Debi Bal (Datta) , the mother of Sri Datta, on 13/03/2024 via registered post with AD RE 41498300IN , but no response was received from Sri Datta.

Subsequently, on 19/08/2024, another show cause was sent to Sri Ajit Datta, LDC via Registered Post (AD No. RE 4074916931 IN). The Postmaster had informed that the AD card was undelivered due to the addressee being out of station, and the premises being locked. The card was returned to this office on 13/09/2024.

Furthermore, on 21/11/2024 this Directorate issued another show cause notice to Sri Datta, LDC regarding his prolonged unauthorized absence, which was also published in four leading local newspaper and in the website of the Department on 27/11/2024 but no reply has been received from Sri Datta. The Inspector of Schools, Satchand, confirmed that a copy of the notice was sent via Registered Post (RE 4196797191), which was again returned undelivered by the Postmaster on 03/12/2024, stating that the addressee had been out of station for a long time and the premises remained locked.

AND

Whereas, Sri Ajit Datta, LDC has been neglecting his office duties wilfully which is unbecoming on the part of a Govt. employee ;

AND

Whereas, as per notification No.F.1(1)-FIN(G)/86 dated 20/06/2013 of the Finance Department and Memorandum vide No.F.20(1)/GA(P & T)/18 (Part) dated 12/12/2018 of the General Administration (P & T) Department, Government of Tripura , a Government servant shall be deemed to have resigned from the service if he is

- (a) absent without authorization for a period of 1 (One) year; or
- (b) remains absent from duty for a continuous period of 5 (Five) years, with or without Leave ;

Now, therefore, as a final opportunity, Sri Ajit Datta, LDC is hereby asked to explain within 31/10/2025 as to why the period of his prolonged unauthorized absence since 06/09/2023 to date should not be treated as deemed to have resigned from service, falling which action will be taken *exparte* .
